

Provenanced and unprovenanced First Dynasty potmarks from Tarkhan

Introduction

The seven tables list provenanced and unprovenanced First Dynasty potmarks from Tarkhan. Currently 344 marks for the site have been identified (Mawdsley 2006a). Of this number, 282 were originally published by Flinders Petrie in *Tarkhan I and Memphis V* (Petrie *et al.* 1913) and *Tarkhan II* (Petrie 1914). The remaining 62 marks have been identified from an examination of Petrie's excavation tomb cards and from searching the catalogues of international museum collections (Mawdsley 2006a: 20). This work is ongoing and the tables will be updated when further data is collected.

Key to tables

The marks in tables 1-4 have been arranged according to the numbers allocated by Petrie on plates XXX and XXXI in *Tarkhan I* and on plates XX and XXI in *Tarkhan II*. In tables 1-2 the letters A-P have been allocated to marks found illustrated on plates other than plates XXX and XXXI in *Tarkhan I*. All new marks in tables 5-7 are arranged by museum accession number or tomb number and are illustrated in Mawdsley (2006a: pls. 10-12). To date the museum locations of 91 marks have been identified and are included in the column headed MAN (Museum Accession Number). The arrangement of the tables follows that adopted by Gilroy *et al* (2001:34-36) and the allocation of a mark to a sign-group follows the corpus of published First Dynasty potmarks compiled by van den Brink (1992).

Brief comments

The allocation of a mark to a sign-group is sometimes based upon a similarity in design rather than to an exact match with a particular sign-group. Such marks are recorded as a form of a particular sign-group, for example a mark may be interpreted as a group III form as it shares some of the characteristics of that sign-group.

A number of marks are too incomplete or unclear to allocate to a sign-group with any confidence while seven marks from tables 5 and 7 were not illustrated in the original source material.

There are also a number of marks unique to the site. Some of these are listed in van den Brink's (1992) corpus as unique forms of particular marks, while others are recently discovered single examples and have no published parallels. Several of the new marks represent additional examples of marks listed in van den Brink's (1992) corpus.

For a more detailed discussion of the marks from Tarkhan the reader is directed to the unpublished thesis by Mawdsley (2006a).
